

## **USER LIMITED USE LICENSE AND CONTRACT AGREEMENT**

Fund Busters agree when using any information on this web site to assume individual responsibility for legal compliance such that CEO Space and IBI Global are held harmless and indemnified from any and all liability related to the fund busting training. Fund Busters using the information specifically warrant to IBI Global, Inc. and CEO SPACE INTERNATIONAL, Inc., (used interchangeably as one entity) by "first use" that the fund buster agrees the Fund Buster program material is a "report" and training of prior fund buster experiences from 1992 to the present whereby all methods and techniques represent actual prior Fund Buster experience not developed initiated controlled or influenced by CEO SPACE INTERNATIONAL, INC, its officers or directors or affiliates. Fund Busters agree to hold CEO SPACE INTERNATIONAL, INC. harmless for any damage or liability real or imagined that may arise from application of fund busting training. Fund Busters agree Fund Busting is limited specifically to a volunteer operated educational program - that, although the Fund Busting training has helped past students, no assurance or warranty can be made the educational product will help future students - that no claim or warranty is made or implied - that as with all education actual application of skill is the sole responsibility of the student without claim or recourse to CEO SPACE or its affiliates. Each Fund Buster studies a dozen or more possible methods for approaching limited, isolated transactions to raise capital, selecting individual methods over which volunteer faculty have no influence or control, such that all volunteer faculty are also held harmless and indemnified or any and all claims or liabilities related to the educational curriculum provided in the Fund Buster lesson plan. The Fund Busting lesson plan is provided at no cost to a worldwide student body and all "users" stipulate that materials are copyright protected, trade secret in nature, and use by the student warrants agreement by contract and "online license" that user implementation grants a stipulated damage clause to CEO SPACE INTERNATIONAL, INC. such that its officers directors and affiliates are entitled to legal fees, damages and stipulated damage fees of \$ 500.00 per day for any dispute to this license and online contract agreement and all Fund Busters proceed at their own risk to implement Fund Busting--such legal compliance and "action" taken from the educational curriculum entitle CEO SPACE to day-by-day legal damages and reimbursement for dispute settlement should any claim be made by users who violate the hold harmless indemnification and limitation terms of this online license and agreement for use rights. The user agrees any

dispute of this limited educational license for no cost study of the online curriculum is covered under the laws of the state of Florida that all dispute settlement costs, including legal and expenses, will be paid in advance by the student user without recourse to CEO SPACE or affiliates - that all clauses remain binding if any part of the license is deemed unenforceable - that the term of the license grant and agreement - is five years from date of user first use of the Fund Buster education - that no substitution of jurisdiction or modification of clause or contract terms may be made - and that any use download study or click beyond the cover page of this educational contract perfects the legal contract and is deemed binding in a court of law - upon the date first use is undertaken. Fund Busting is void in any jurisdiction in which prohibited by law. NO modification to the terms of this self study limited use license for curriculum may be made or claimed by either party and all curriculum material is precluded where prohibited without law and is deemed null and void in such instance as may apply to any worldwide legal jurisdiction without exception or as may be advised by independent legal counsel Fund Busters warrant they have engaged prior to taking action on curriculum within the wide scope general non specific Fund Buster lesson plan. This agreement is the full and complete agreement between the Fund

Disputes may not be made in any public manner until resolved by a court of law without evoking stipulated damages clauses of \$ 500.00 per day or as shall be awarded by a court of law.
